## **COMMUNITY CLEAN UP**

Welcome new homeowners. January 2015 was a good year for sales in Heron Walk. YTD ten properties have sold. With the help of proper maintenance, several homes sold for \$150,00.

Unlike your typical single family residential neighborhood, The Declaration of Covenants and Conditions & Rules and Regulations has standards for maintaining property values. No one is excluded. We thank all new owners for making the choice to reside in Heron Walk. As administrators, we will continue to work with all residents in maintaining the exterior of their home and the community we all share.

In August, a letter went out to all homeowners. Each homeowner was notified to clean the exterior of their

home if it was soiled.. The response was fairly good however we still have some deficiencies/violations which are currently being worked on with the homeowner. An audit was conducted in Heron Walk late September of this year. Each lot and the home exterior was inspected for cleanliness and damage, etc. During this inspection it was noted there were homes which were heavily soiled, exterior damage, wrecked vehicles. There was also evidence of fences which were badly damaged, not to mention the numerous Code violations which were sited. One of our primary goals is to maintain property values. The objective of the Board is to reduce number of these violations by enforcing the rules and regulations of the community. As an effort in keeping the promise we will continue to have seasonal inspections in Heron Walk.
